The Committee discussed options for increased density. Mr. Angell noted that, outside of the PDD, there are opportunities for increased density through average density zoning. He explained to the Committee the difference between average density subdivisions and cluster subdivisions. He also noted that the Town used to have two acre zoning in some areas and that by looking at an old map they could determine where those areas were, though he believed they must be located on the best soils.

The Committee discussed affordable housing definitions, and the cost of development of various housing options.
